# **REGISTRATION NOTES**

- Students may take Lawyering Seminar III in their fourth semester and clinic in their fifth semester or take Lawyering Seminar III in their sixth semester and clinic in their seventh semester.
- Students with a cumulative GPA of 3.3 or higher by the end of their seventh semester may opt out of this requirement and take additional elective credits to satisfy graduation requirements.
- Evening students can waive the bar elective requirements if they have a cumulative GPA of 3.3 or higher after their fourth semester.

## DISTANCE LEARNING (ONLINE CLASSES) RULES

• Only 15 online course credits will count towards the J.D. degree.
