As part of the Law School's goal to increase access to justice for underserved communities, CLRN engages experienced CUNY School of Law alumni as independent contractor attorneys to deliver legal information, counseling, un-bundled, limited- scope assistance, and helpful referrals, and to demonstrate the value of our brand of public service throughout the City. This programming is made possible by funding from various members of New York City Council and New York State Legislature.

### **POSITION OVERVIEW & RESPONSIBILITIES:**

CLRN will contract Independent Contractor Attorneys to deliver professional, high quality, efficient and compassionate limited scope legal assistance, as well as Know-Your-Rights presentations. Independent Contractor attorneys will be placed in New York City Council Member Offices or a designated trusted Community Based Organization, where they will assist constituents on a range of legal matters. Legal service areas include housing, immigration, family, public benefits, elder law, small business and general civil litigation.

The duties of the Independent Contractor Attorney include:

- Meet one-on-one with clients to review and assess legal needs, provide limited scope legal advice, prepare and review basic legal documents, and/or refer constitutions for further legal assistance or related services.
- Deliver Know-Your-Rights presentations of legal material to groups or office staff. (not at all sites)
- Interface with community-based site with professionalism and willingness to work with staff to be pro- active in optimizing service delivery.
- Maintain accurate and current records, including entry of program data on survey tool.
- Attend any required trainings and meetings.

- Minimum four (4) years of experience delivering direct legal services
