*Flourish or Founder: The New Regulatory Regime in Legal Education*, 44 J. L. & Educ. 473 (2015).

Outside regulators, whether nationwide or state specific, are seeking to alter the education and training provided by U.S. law schools. These new mandates build on decades of work distilling how best to provide a professional legal education. Law schools have long fought outside reform; we do so now at our peril. This Article explores the current reforms, places them in historic context, and then articulates how legal educators should engage with the reforms to recenter student learning.

When Your Attorney Is Your Enemy: Preliminary Thoughts On Ensuring Effective Representation For Queer Youth, 19 Colum. J. Gender & L. 773 (2010).

This article uses case narratives to illustrate the effects - good, bad, and ugly - of an attorney's bias toward sexual minority children. Then using the experiences of one transgender youth, the article explores potential remedies a queer child may have when they are injured by their attorney's actions.

# Legal Research as a Fundamental Skill: A Lifeboat for Students and Law Schools, 39 U. Balt. L. Rev. 175 (2010).

This article suggests that current legal research education is dangerously deficient and demonstrates how it can be reconceptualized to become a synergistic first year course that supports the learning of doctrine and legal analysis, as well as necessary research skills in accordance with recent suggestions by the ABA, the authors of the Carnegie Report, and other legal commentators.

*Traditional Advocacy For Nontraditional Youth: Rethinking Best Interest For The Queer Child*, 2008 Mich. St. L. Rev. 1053.

The Article argues that attorneys representing queer children--those children who either self identify or are perceived by others as being a sexual minority or who do not conform to normative gender roles--must provide traditional zealous advocacy to their queer child clients. The heterosexism that pervades our culture also afflicts the attorneys who represent this population, tainting their ability to represent their clients in a conscientious, ethical, and effective manner. The article concludes with a model rule, which would prohibit all but traditional representation for queer children.

*Queer Kids: A Comprehensive Annotated Legal Bibliography on Lesbian, Gay, Bisexual, Transgender and Questioning Youth,* 19 Yale J. L. & Feminism 449 (2008). This forty-four page annotated bibliography is a comprehensive collection of law review articles, and selected other materials, relevant to lesbian, gay, bisexual, transgendered, and questioning youth. It is intended as a resource for scholars, policymakers, and practitioners, this bibliography collects, discusses, and organizes legal scholarship, selected reports and studies, and influential personal narratives from queer kids.

*Ruth Bader Ginsburg: An Annotated Bibliography*, 7 N.Y.City L. R. 391(2004). As the first annotated bibliography of Ginsburg, this sixty page annotated bibliography was intended to assist researchers studying the life and legal career of Justice Ginsburg. It organizes Ginsburg's prolific and varied articles by subject and also provides annotations of books and legal articles written specifically on Justice Ginsburg by other scholars.

Lov(h)ers: Lesbians as Intimate Partners and Lesbian Legal Theory, 63 Temple Law Review 511 (1990) (co-authored).

This early co-authored article argues that the legal mechanisms available to lesbians negotiating their "extra-legal" status must be analyzed from a lesbian-centered vantage point.

*Supporting Queer Youth*, in Justice for Kids: Keeping Kids Out of the Juvenile Justice System (Nancy Dowd, ed. N.Y.U. Press 2011).

The chapter develops a public health framework for addressing the discrimination and violence facing queer youth. It draws on the macro level prevention methodologies employed by some in the intimate partner violence movement, discusses integrating similar strategies into community institutions and offers specific techniques to assist activists in implementing these strategies.

*Leveraging Legal Research,* in Vulnerable Populations and Transformative Law Teaching: A Critical Reader, (Society of American Law Teachers, Golden Gate University School of Law, eds. 2011).

The chapter discusses the potential for a legal research course restructured within a specifically social justice framework to become a first year course that links doctrine while simultaneously fostering student engagement.
