# **Legal Research Faculty Publish Custom Textbook**

Publishing a course textbook may seem like a daunting task. but not for CUNY Law's legal research faculty who published a textbook, Progressive Legal Research, in Fall 2013. CUNY Law has included legal research as a required 2 credit course for its 1st year students since its opening in 1983. Although classes are taught and graded independently by the school's faculty law librarians, the approach to teaching legal research and preparing course materials has always been a collaborative effort. In past

years, the legal research curriculum included assigned readings from commercially published textbooks as well as extensive handouts created by the legal research faculty. Often wishing they could combine what they thought were the best sections of related textbooks and blend them with their own materials, a custom textbook created by the legal research faculty was a welcomed solution. Wolters Kluwer's Aspen Custom Publishing Series permits copyrighted text and graphics from selected textbooks to be

used with original materials to create a custom book. An original title and cover design on a quality publication under the name of a recognized publisher gives the new text a professional look. And something as simple as using a picture of CUNY School of Law as the cover design for the book has generated interest in the textbook among CUNY Law students and administrators alike. The New York Times Digital is now available to all CUNY Law students, faculty and staff due to the generosity of CUNY Central:

1. Go to nytimes.com/AcademicPass.

2. Click on "Register" to create a NYTimes.com account using your law school e-mail address.

You can enter a new password or use your existing password if you prefer. IF YOU'VE REGISTERED IN THE PAST WITH NYTimes.com USING YOUR LAW SCHOOL E-MAIL ADDRESS, click the "Log In" button for returning users and skip to Step 5.

3. Select the e-mails you'd like to receive from the NY Times

then click "Create My Account."

4. On the Welcome page, click "Continue."

5. You will then see "Check your email." Look for a "Confirm your email" message from the NY Times in your law school e-mail account (it should arrive within 15 minutes.)

6. Click on the link in this confirmation e-mail.

#### So, the first question to be addressed is one that impacts all of us:

# Q. Why do I need a library barcode? I thought that access to CUNY databases on the web and use of other CUNY libraries was free and unfettered?

A. Library barcodes serve a dual purpose. In order to use online databases from home, you will be asked to enter your barcode number after you click on a link to a subscription-based online resource from the library's webpage or from the online catalog. Also, a barcode is required in order to borrow books from other CUNY campus libraries. If you do not have a library barcode on the back of your CUNY Law ID card, see Kathy Williams or Ricardo Pla at the library's Circulation Desk.

Jonathan Saxon Associate Law Library Professor and Electronic Resources Coordinator
